



BUS SERVICE TO MOORE & HARNETT COUNTIES School Year 2018-19

Dear Parents,

Thank you for the opportunity to partner with you in the education of your children. We are glad to be able to offer a bus service to the Moore and Harnett County area again for the 2018/19 school year. If you are planning to send children to school on the bus, please complete this registration form and turn it into the Finance Office. We ask that you be prompt to pick up your children; however there is a grace period of 5 minutes, and the bus driver will leave no child unattended.

The Moore County bus will depart from Seven Lakes Baptist Church every morning at 6:35, and they will travel on to Cannon Park in Pinehurst to pick up at 6:55, with the final stop at Pete's Restaurant and Pizza Hut in Carthage at 7:05. The afternoon bus will arrive at Pete's Restaurant at 3:25, at Seven Lakes at 3:40, and Canon Park at 4:00.

The Harnett County Route will have three stops as well. The first stop will be at Spout Springs Church at 6:40 in the morning, then to the Carolina Lakes Marina at 6:55, and finally at Swan Station gas station at 7:15. Your afternoon bus stop arrival times are Swan Station at 3:35, Carolina Lakes at 3:55, and Spout Springs at 4:05.

NOTE: These are APPROXIMATE times and may vary due to the number of riders at each location.
